Purpose of processing data

- Scandinavian Society of Forest Economics (SSFE) membership register is maintained to enable communication to the Society's members about the activities and publications of the SSFE as well as important notices relating to forest economics from the Nordic Countries. Legal basis for data processing

Data processing is legally based on the article 6.1(a) of the EU General Data Protection Regulation (GDPR): "the data subject has given consent to the processing of his or her personal data for one or more specific purposes". <http://www.privacy-regulation.eu/en/6.htm>, [Finland's] Data Protection Act ([1050/2018](https://www.finlex.fi/en/laki/kaikkivaltainen/2018/1050)).

Personal data categories

Data in the SSFE membership register: first and last names, academic affiliation and its country, email address, gender (man, woman, other, does not want to tell, no information), status as a PhD student (yes, no, no information).

Sources of personal data

The information is collected from the person himself/herself via SSFE event registration forms or by email.

Retention period of personal data

Personal data will be deleted i) if the person's academic email address has discontinued and if consent of maintaining the information is not received from another email address; ii) if the person asks his/her data to be removed from the register; or iii) in case of SSFE closure according to its Bylaws (<https://www.ssfe-network.org/about/bylaws/>).

Data handlers

Data receiver groups

The SSFE membership register data may be temporarily handed over to nominated secretaries/assistants of SSFE events organization committees for specific tasks performed when preparing for and communicating about the events.

Transfer of information outside the EU or EEA

Data will not be transferred outside the EU or the European Economic Area.
